Rebecca Painter, ASSESSOR was present, she reported that exemption forms are done. She is taking classes and training courses to help her in the job. Notice of assessments were sent out. May 28, 2024 is the date of the Board of Review.

Mary Shupp, PLANNING BOARD, was present.

James Martin, HIGHWAY SUPERINTENDENT – Reported the following:

- The New roller was delivered.
- The Old one was sold at auction. Once the buyer pays, the check to Woodhull will be sent out.
- The highway crew is working on filling potholes.
- The Highway crew is working on pipes.
- He talked about renting the equipment last year from the Milton CAT stating we still owe money for the rental. They explained that they have 13 months in a year. 28 days per month and the rest is in the 13th month.
- He would like to sandblast and paint a truck bed. There are 3 quotes for the sandblasting, but the lowest bid needs more documentation, Jim will go and see the person and get the paperwork.
